

Terms and conditions of the prize

Pre-registering does not automatically place you into the draw to win the wedding. You and your other half **MUST** attend the Win A Wedding Fair on Sunday 12 May 2024, 11am-2pm at the Grand Opera House York in order to be counted in the draw and entered officially to win this prize.

One winning couple will be drawn at random by YorkMix from all couples who have attended the Wedding Fair at the Grand Opera York House taking place on Sunday 12 May 2024 between 11am and 2pm, and one prize is available. No swaps or changes will be allowed. Should YorkMix be unable to contact the winner within 2 days, the prize will be given to another entry chosen at random. The winner of this competition will be contacted on Monday 13 May 2024.

All couples wishing to enter this competition **MUST** have attended the Wedding Fair at the Grand Opera House York between 11am and 2pm on Sunday 12 May to be entered into the draw to win the wedding. Late entries will not be counted.

All couples wishing to enter this competition **MUST** attend the wedding fair as a couple to enter in person and cannot send any representatives to enter on their behalf. Entries will not be accepted by anyone other than the couple wishing to win the wedding or these entries will not be counted.

No cash alternative to the prize will be available. Upgrades may be available for additional guests or enhanced alcohol packages. Additional costs over and above the prize package will require full payment one month prior to the wedding date.

The specifics of each prize shall be solely determined by ATG / YorkMix. The prize is non-transferable. Any and all prize-related expenses (including but not limited to additional food and drink, decoration or travel and accommodation) shall be the sole responsibility of the Winner.
